## Environment, Social and Governance (ESG) Initiatives

IFPW is focused on effecting change is through environmental, social and governance (ESG) initiatives that are right for our Industry and for advancing the intents of ESG. IFPW is working diligently to communicate and share ideas across its networks, and has convened an advisory group of industry representatives to help drive the conversation and share solutions. Through collaboration, IFPW is working to harmonize industry requests and responses through an ESG Framework that can be referenced by pharma wholesalers, manufacturers, and other relevant organizations. These resources, and the underlying standards, will help to move the industry as a whole in a direction that provides less waste, more carbon neutrality, and a more fair and equitable system for access to medicines for all patients.

IFPW, along with IQVIA, is working with organizations to link this ESG framework to external reporting standards and to provide examples of metrics that can be used to measure company performance.

Included in this effort is finding solutions to climate and social issues. With the advent of the pandemic, it became clear that disparities continue to exist worldwide in the availability of quality and affordable medicines, as well as basic healthcare services. These marginalized populations can be identified so services can be delivered, reaching more patients regardless of ethnicity, economic prosperity, or location.

## IFPW Foundation's Initiatives

### Gavi The Vaccine Alliance - A Partnership Rooted in Collaboration

- ◆ Initially supported two healthcare supply chain Centers of Excellence (EAC and LOGIVAC centers) in East and West Africa
- ◆ STEP Leadership - A program to develop foundational leadership skills in public health supply chain workers with the support of private-sector coaches
  - Member involvement through facilitation/coaching
- ◆ 2021-2025 Expansion/Focus
  - STEP Program Expansion (Geographic and Virtualization)
  - Supply Chain Innovation
  - Supply Chain Design/redesign support
  - New collaborations with other donors (Global Fund, USAID, etc.)

### Fight the Fakes Alliance (FtF)

The mission of FtF is to raise awareness around falsified and substandard medicines, as well as advocate for legislative and regulatory action to address the problems and challenges these falsified and substandard medicines pose globally.

Members and stakeholders of the FtF Alliance convene to share best practices and effective solutions. FtF also provides support to patients and consumers adversely affected by falsified and substandard medicines.

- ◆ IFPW co-served as Secretariat in 2019 and 2020 with IFPMA
- ◆ Evolved from an information campaign to a new alliance in January of 2021
- ◆ IFPW currently serves on the Executive Board
